TERMS AND CONDITIONS

1. The vehicle must be driven by the client named above in Part 1 (referred to as 'Lessee' from now on) with care and attention, within speed limits and without excessive trips or cargos.
2. The vehicle may not be driven by anyone else except the lessee even if the other person is in possession of a valid driver's licence.
3. The lessee is responsible for any damage done to the vehicle due to careless driving or poor engine checks (oil and water) or insufficient tyre pressure checks.
4. Should any mechanical problems occur, the lessee must go to the nearest mechanics for any necessary repairs and will be reimbursed for any repair charges once a valid invoice is provided in the name of SALENTOAUTONELEGGIO SRL (referred to as 'Lessor' from now on). Any repairs over €30 must be authorised first by the lessor. The lessor is not obliged to supply a replacement vehicle should the rental vehicle breakdown.
5. The lessee is responsible for the payment of any fines incurred and these fines will be sent to the lessee's home address as provided above in Part 1.
6. The lessee is responsible for any damage caused to the vehicle up to a maximum of €1,700.
7. In the case of vehicle theft where the keys are not returned to the lessor, the lessee must pay the total value of the vehicle.
8. Within 24 hours of any accident or breakdown occurring, no matter how small, the lessee must contact the lessor to provide full details of the incident.
9. A deposit of € _____ must be paid by the lessee (in cash or by credit card) before receiving the keys to the vehicle. The deposit will be reimbursed in full once the vehicle is returned in the same condition in which it was provided. The deposit will be kept by the lessor should there be any minor damage done to the vehicle during the rental period.
10. Full insurance coverage is available at an extra charge of 20% of the total rental cost. With this insurance cover, the amount to be paid by the lessee in the case of any vehicle damage or theft will be a maximum of €300.
11. If the lessee is under 21 years of age or is in possession of a driver's licence for less than 12 months then an extra cost of €5 per day will be charged.
12. The cost for adding any extra drivers is €15 per driver.
13. If the vehicle is returned one hour or more later than stated above in Part 2 then the lessee will be charged for an extra day's rental (except in cases where the lessor is aware of and in agreement with a later return time).
14. An extra charge of €10 will be applied if the vehicle is required or returned outside of normal working hours.
15. An extra charge of €10 will be applied if the vehicle is returned in a particularly dirty condition (either the inside or the outside of the vehicle).
16. The vehicle comes with a sealed odometer, standard equipment (high visibility vest, a high lift jack, tyre/lug wrench, spare wheel or tyre repair kit), radio and vehicle registration and insurance documents. The vehicle may also be equipped with a navigation system.
